Privacy Policy

One of UCM Alumni Foundation’s most important functions is to keep alumni and supporters connected to UCM and to each other. Consequently, the UCM Alumni Foundation (the Foundation) compiles both public and private information about alumni and supporters. This notice is to inform you of how the Foundation uses the information it collects and how you can limit that use.

The UCM Alumni Foundation collects information about alumni and supporters from various sources:

- Information alumni and supporters send to the Foundation, whether through correspondence, applications, email, surveys, etc.
- Information the Foundation receives from its affiliates
- Information the Foundation receives from alumni records, which is a matter of public record

The Foundation’s database is for the sole use of UCM and the Foundation. It does not sell, rent, or trade alumni and supporter information with any organization that isn't directly affiliated with UCM. For your reference, you can read additional about what kinds of information this website collects and why.

UCM Alumni Foundation Affiliates

The Foundation works closely with the UCM colleges and schools, regional alumni chapters, and affinity alumni groups. It shares information openly with these organizations.

The Foundation also has formed relationships with companies to provide certain services to alumni and supporters in order to generate revenue that finances the services that UCM provides to alumni, supporters, and students. The Foundation considers these companies' practices regarding use of customer information and determines whether each company is a reputable, trustworthy organization before entering into a partnership.

These companies communicate directly with alumni and supporters to market products and services that they vend for the Foundation. For this purpose, the Foundation provides lists of names and addresses, with a detailed contract governing the use of these lists.

If you do not wish to be contacted by these companies, notify the Foundation as explained in the "Opt-Out Option" section of this page. The Foundation will then remove your name from these mailing lists. Please be aware that mailings often are prepared several weeks in advance of shipping.

How Does the UCM Alumni Foundation Use Contact Information?

The Foundation uses contact information to contact alumni and supporters with information about UCM, alumni affairs activities, and fundraising opportunities through mail, phone, and web-based communication tools like e-mail and social media networks.

Security

The Foundation takes precautions to protect your information. When you submit sensitive information via the Foundation website, your information is protected both online and offline.

Wherever we collect sensitive information (such as credit card payment information) the information is encrypted and transmitted to use in a secure way. You can verify this by looking for a closed lock icon at the bottom of your web browser, or looking for "https" at the beginning of the address of the web page.

While we use encryption to protect sensitive information transmitted online, we also protect your information offline. The computers and servers in which we store personally identifiable information are kept in a secure environment.

The Foundation employees view your personal information when necessary to serve you. All Foundation employees and UCM employees with access to the Foundation database are required to adhere to a Confidentiality Policy.

Photography

Photos or video taken at our events may be used in publications such as brochures, newsletters, magazines, and video presentations. Such photos or videos may also be used electronically in online publications, our websites, e-mails, social networking sites such as Facebook or Twitter, or in other electronic forms of media. If you are pictured and would like us to discontinue using the photo, please contact us.

Online Transactions

The Foundation uses Blackbaud Merchant Services to host our website and to accept and process contributions via credit card. When using the site to make a donation, Blackbaud collects information as described in its privacy policy. Blackbaud uses that information to complete the transaction and will share that information with the Foundation, which is stored in our local secure database.
